## RESOLUTION SBPC #2346-01-24

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO COMPLETE AND SUBMIT THOSE DOCUMENTS AND AGREEMENTS REQUIRED IN CONNECTION WITH THE COMMUNITY WATER ENRICHMENT FUND (CWEF) 2023-2024 GRANT APPLICATION IN THE SUM OF \$140,000.00 TO THE STATE OF LOUISIANA TO INSTALL A NEW 12-INCH DIAMETER STEEL POTABLE WATER FILL LINE ON THE REGGIO WATER TOWER FOR THE PURPOSE OF IMPROVING DRINKING WATER QUALITY FOR THE RESIDENTS OF EASTERN ST. BERNARD PARISH.

**WHEREAS**, the Public Works Department is responsible to provide safe drinking water and fire protection to the residents of St. Bernard Parish; and,

**WHEREAS**, there is a need for the Public Works Department to install a new 12-inch diameter steel potable water fill line at the Reggio Water Tower and,

**WHEREAS**, the purpose of CWEF is to assist local governments with grant funding, with no match or reimbursement required from the recipient or Parish, for rehabilitation, improvement, and construction projects on community water systems for eligible Parishes in the amount of \$140,000.00; and,

**WHEREAS**, the grant will allow the Parish to use the grant in the amount of \$140,000.00 to install a new 12-inch diameter steel potable water fill line at the Reggio Water Tower.

**NOW, THEREFORE, BE IT RESOLVED** by the St. Bernard Parish Council, acting as governing authority of said Parish

**SECTION 1.** That the St. Bernard Parish Council does hereby authorize the Parish President to complete and submit those documents and agreements required in connection with the Community Water Enrichment Fund (CWEF) 2023-2024 grant application totaling \$140,000.00 to the State of Louisiana to assist the Public Works Department with the installation of a new 12-inch diameter steel potable water fill line at the Reggio Water Tower.
