On motion of Mr. McCloskey, seconded by Mr. Moran, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2350-02-24**

A RESOLUTION CANCELING AN ELECTION CALLED BY A RESOLUTION ADOPTED ON DECEMBER 19, 2023, TO AUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN, AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

**WHEREAS**, the Parish Council of the Parish of St. Bernard, State of Louisiana (the "Governing Authority"), adopted Resolution SBPC #2342-12-23 on December 19, 2023 ordering and calling a special election to be held in the Parish of St. Bernard, State of Louisiana (the "Parish"), on Saturday, April 27, 2024 to authorize the levy of a special tax therein (the "Election Resolution"); and

**WHEREAS**, it is now the desire of the Governing Authority to cancel the election to be held in the Parish on said date;

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Authority, acting as the governing authority of the Parish, that:

**SECTION 1.** The election to be held in the Parish of St. Bernard, State of Louisiana, on April 27, 2024 for the purpose set forth above is hereby canceled.

**SECTION 2.** The Election Resolution SBPC #2342-12-23 is hereby rescinded.

**SECTION 3.** The Governing Authority is hereby authorized and empowered to (i) furnish a copy of this resolution to all election officials and officers charged with conducting the April 27, 2024 election, and (ii) notify said election officials and officers that said election has been canceled.
