A RESOLUTION ENDORSING A LETTER TO CONGRESSMAN STEVE SCALISE, IN SUPPORT OF THE REQUEST BY THE ST. BERNARD PARISH SHERIFF'S OFFICE FOR THE FISCAL YEAR OF 2025 FROM ACCOUNT COMMERCE, JUSTICE, SCIENCE COPS TECHNOLOGY AND EQUIPMENT FOR THE PURPOSES OF RADIO EQUIPMENT UPGRADES.

WHEREAS, the St. Bernard Parish Sheriff's Office is located in Southeast Louisiana with an approximate population of 45,000 people; and,


