On motion of Mr. Randall, seconded by Mrs. Mones, it was moved to **adopt** the following resolution.

RESOLUTION SBPC #2362-04-24

A RESOLUTION TO CALL A SPECIAL ELECTION TO FILL THE VACANCY IN THE OFFICE OF CONSTABLE, WARD F WITHIN THE PARISH OF ST. BERNARD.

WHEREAS, Pursuant to La. R.S. 18:583, an anticipated vacancy has occurred in the above-specified office; and,

WHEREAS, the Governing Authority shall therefore within twenty (20) days call a special election in accordance with La. R.S. 18:402 and La. 18:602 on or before April 8, 2024; and,

WHEREAS, the unexpired term of said office exceeds one year, and;

WHEREAS, Ward F is wholly located within the boundaries of the Parish of St. Bernard.

NOW, THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority, does hereby proclaim the following:

SECTION 1. That a Special Election be called for November 5, 2024 Primary Election and December 7, 2024 General Election with qualifying dates of July 17,18, & 19, 2024.

SECTION 2. The Clerk of Council shall forward certified copies of this Resolution calling the election as well as the certified minutes of the meeting by certified mail within twenty-four (24) hours to the Louisiana Secretary of State, and the St. Bernard Parish Clerk of Court in accordance with Louisiana Revised Statutes 18:602.

BE IT RESOLVED, that if any provision or item of this Resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this Resolution which can be given effect without the invalid provisions, items or applications and to this end, the provisions of this Resolution are hereby declared severable.



Dear Ms. Adams:

In accordance with La. R.S. 18:653, I am enclosing a copy of the resignation received on March 18, 2024 by our office from the Honorable Hillary T. Miller as Constable, Justice of the Peace Ward F, Parish of St. Bernard with an effective date of March 31, 2024.

Pursuant to La. R.S. 18:583, an anticipated vacancy has occurred in the above-specified office. The governing authority shall therefore within twenty (20) days call a special election in accordance with La. R.S. 18:402 and La. R.S. 18:602 (**on or before April 8, 2024**). The next available election is scheduled for November 5, 2024 (primary) and December 7, 2024 (general), with qualifying dates of July 17, 18, & 19, 2024.

Additionally, pursuant to La. R.S. 18:583(D)(1) and La. R.S. 18:602, the governing authority shall within twenty (20) days of the office actually becoming vacant (**after March 31, 2024 but before or on April 22, 2024**) make an appointment to fill the office.

After a proclamation is issued calling the election and an appointment has been made, a certified copy of the proclamation calling the special election as well as the certified minutes of the meeting in which the appointment was made or certified resolution, should be mailed to our office. A commission will be issued to the person appointed to fill the vacancy.

If the governing authority does not timely call the special election and/or make an appointment, we will forward a request to the Governor to do so pursuant to La. R.S. 18:602.




