AN ORDINANCE TO **AMEND** CHAPTER 16; PARKS AND RECREATION; SECTION 16-9, CURFEW IN PARKS AND PLAYGROUNDS OF THE ST BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby **amend** Chapter 16; Parks and Recreation; Section 16-9, Curfew in Parks and Playgrounds of the St. Bernard Parish Code of Ordinances as per attached in Exhibit “A”.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon the authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.





Chapter 16 – Parks and Recreation
Section 16-9 – Curfew in parks and playgrounds

Section 16-9 – Curfew in parks and playgrounds

The following terms, phrases and words, when used in this article, shall be construed to have the following meanings:

(a) *Definitions.*

"To loiter" means to remain in an area for no obvious reason; to dawdle.

"To access" means to enter the area.

- (b) *Curfew:* It shall be unlawful for any person to loiter in Torres Park, formerly known as Parc Chenier, or adjoining parking areas between the hours of 8:00 p.m. and 5:00 a.m. central standard time.

It shall be unlawful for any person to access the following parks between the hours of 8:00 p.m. and 6:00 a.m., central standard time:

1. Marietta Park-3400 Marietta
2. Heights Park-1916 Alexander
3. Community Park-801
4. Lena Park-2205 Lena
5. Judy Dr, Park-3500 Judy Dr.
6. Cypress Park—Paul and Claiborne Ave.
7. Blue Bird Park-28 E. Chalmette Circle
8. Francis Place Park-Francis Ave. and Claiborne Ave.
9. Angelique Park-Shannon and Florida Ave.
10. Riverbend/Reunion Park-Riverbend and Reunion St.
11. Violet Playground-6609 E. St. Bernard Hwy.
12. Jena Park
13. Palmisano Park-1201 Missouri St.
14. Dog Park-6998 Bienvenu (Arabi)
15. Village Square Chip & Putt

- (c) *Violation; Penalty* Whoever violates the provisions of this section shall be fined not less than one hundred fifty dollars (\$150.00) and not more than five hundred dollars (\$500.00) or imprisoned for not more than six (6) months or both. The minimum fine shall not be suspended.
