On motion of Mrs. Mones, seconded by Mr. McCloskey, it was moved to adopt the following resolution:

RESOLUTION SBPC #2374-05-24

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO AGREE TO A WATER & SEWER RATE STUDY AS REQUIRED BY THE WATER SECTOR PROGRAM IN ORDER TO RECEIVE CURRENT AND FUTURE GRANT FUNDING.

WHEREAS, St. Bernard Parish is currently set to receive approximately \$3,000,000 for water projects and \$6,000,000 for sewer projects under the Water Sector Program; and,

WHEREAS, the Water Sector Program requires St. Bernard Parish to agree to a Water & Sewer rate study in order to receive said funds in addition to any future funding; and,

WHEREAS, the State Office of Community Development – Local Government Assistance will assign a firm to complete said study; and,

WHEREAS, the Parish agrees to implement the new Water & Sewer rates as determined by said rate study; and,

WHEREAS, St. Bernard Parish will not be eligible for current or future funding in the event that the Parish does not implement said rates.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the Governing Authority, does hereby authorize the Parish President of St. Bernard Parish Government to allow the State Office of Community Development perform a Water & Sewer rate study and agree to implement the rates as determined by the study.
