Since my last update there have been many notable accomplishments, developments, and events, in addition to the daily function of parish government as a whole. This report lists some, but not all, of the recently completed repairs, replacements, or tasks undertaken by employees of St. Bernard Parish Government. This is not an exhaustive list, but it is my aim to be transparent, informative, and available to the residents, business owners, and stakeholders of this community as we forge ahead in prosperity and positivity.

St. Bernard Parish Government, along with our elected officials, and community partners, had an incredibly successful and productive "St. Bernard Day at the Capitol" in Baton Rouge last Wednesday. This event, which is well attended, highly visible, and highly anticipated by our state lawmakers and representatives, serves to showcase and share everything we love about St. Bernard Parish, during the legislative session at our State Capitol.

St. Bernard Day at the Capitol is one of our best opportunities to educate and network, building stronger working relationships with our delegation, and other Louisiana officials and representatives, when we bring a little bit of St. Bernard over to their doorstep. We proudly served delicious chargrilled oysters, fresh from St. Bernard Parish waters and grilled on-site. Local restaurant Today's Catch was there, proudly serving the tastiest fried Louisiana shrimp and delicious seafood, a spectacular representation of our thriving seafood industry and vibrant culinary heritage. They distributed full copies of the report published after a recent impact study, and other literature and information expressing the concerns of many in our community. This is just one example of the networking, advocacy, and meaningful dialogue that took place at this event, all thanks to the partnerships, involvement, and generosity of so many officials, citizens, organizations, and businesses in our community.

Mid-April – May 2024 President’s Report

From the Office of Parish President Louis Pomes

May 07, 2024

Public Works and Infrastructure:

*all of this work was done in-house by our SBPG road yard crews.

- Skimmed ditches on; St. Bernard Hwy. from Webster to Paul Dr. (northside), on Suzi Park, on Russell Dr. and Bayou Rd.
- Repaired 6 dead-end barricades on Creely ditch, and 1 on Dove St. at Margaret Ln.
- Installed dead-end barricade on Charles Ct.
- 1.5 yards of concrete poured on Bear St. in Arabi to repair 18’x4’ sidewalk trip hazard.
- 1.5 yards poured on Cougar in Arabi, to repair/replace an 18’ sidewalk and manhole cover.
- 1 yard poured on Rowley St. in Arabi to repair 13’ sidewalk.
- 1 yard poured on Patricia St. in Arabi to repair/replace 18’ sidewalk.
- A two-phase street repair in the 400 block of Bear St. in Arabi. Phase One saw 11.5 yards of concrete poured to repair a 30’x12’ section of the street. In Phase Two 8.5 yards were poured to repair another 26’x12’ section.
- On Van Cleave Dr. in Meraux, 27’ of curb was repaired/replaced, as well as a 8’x6’ catch basin repair with 3 total yards of concrete poured there.
- Also in Meraux on Van Cleave Dr., from Florida Ave. to Stella Dr., we repaired/replaced 106 linear feet of curbing, pouring 2 yards of concrete there.

Total yards of concrete poured: 30 yards

Updates from DOTD:

- Addressed damaged/missing signs on Paris Rd. and replaced the faded signs at the intersection of Judge Perez and Packenham Ave on the signal mast arms. The old construction sign near LA 46 was also removed.
- Raised pavement markers were installed between the skip marks of Judge Perez from Norton Ave to the Violet Bridge in both directions.
- Road striping on Judge Perez from Norton Ave to the Violet Bridge is still pending, but our striping crew will address the elephant tracks that are faded at the intersections of Judge Perez and Packenham Dr and Archbishop Hannan Blvd next.
