AN ORDINANCE TO AMEND ORDINANCE SBPC #1230-12-10 AND REDESIGNATE THAT PORTION OF DAUPHINE STREET RUNNING BETWEEN MEHLE STREET AND ANGELA STREET AS A TWO-WAY STREET.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That St. Bernard Parish Council does hereby amend Ordinance SBPC #1230-12-10 to redesignate that portion of Dauphine Street between Mehle Street and Angela Street as a two-way street.

SECTION 2. That this ordinance being an ordinance affecting the public peace, health and safety, shall be in full force and effect immediately upon its adoption, and that all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed. In the event of a presidential veto this ordinance shall become effective upon a two thirds favorable vote of the total membership of the Council pursuant to Section 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

AN ORDINANCE CREATING A ONE WAY STREET (EXCEPT FOR EMERGENCY VEHICLES) ON DAUPHINE STREET IN THE DIRECTION STARTING FROM MEHLE STREET TOWARDS ANGELA STREET FOR THE ABILITY OF MAIL DROP OFF DIRECTLY FROM PERSONAL VEHICLES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION I. That St. Bernard Parish Council does hereby create a one way street with the exception of emergency vehicles that will allow mail "drop off" directly from personal vehicles.

SECTION II. That this ordinance being an ordinance affecting the public peace, health and safety, shall be in full force and effect immediately upon its adoption, and that all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed. In the event of a presidential veto this ordinance shall become effective upon a two thirds favorable vote of the total membership of the Council pursuant to Section 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION III. Severability. 


