THE BOARD OF COMMISSIONERS OF THE PORT OF NEW ORLEANS" BEARING DOCKET NUMBER 23-1006 OF THE THIRTY-FOURTH JUDICIAL DISTRICT COURT.

WHEREAS, the St Bernard Parish Council reserves the right to view any official documents presented to the courts before it is submitted into the official record; and,

WHEREAS, this document will be introduced and adopted as an Ordinance if used in its official legal capacity.

NOW THEREFORE BE IT RESOLVED, the St Bernard Council, the Governing Authority, does hereby authorize that the District Attorney shall name the Council and each of its members in their official capacities as an additional plaintiffs and petitioners against the Port of New Orleans and St. Bernard Port in the lawsuit entitled "St. Bernard Parish Government v. The Board of Commissioners of the Port of New Orleans" bearing Docket Number 23-1006 of the Thirty-Fourth Judicial District Court.


