BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, JULY 2, 2024 AT SEVEN O'CLOCK P.M.

On motion of Mr. Moran, seconded by Mrs. Cusimano, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2393-07-24

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO DEVELOP AND SUBMIT AN APPLICATION TO THE DELTA REGIONAL AUTHORITY COMMUNITY INFRASTRUCTURE FUND IN THE AMOUNT OF \$2 MILLION FOR THE CONSTRUCTION OF THE ST. CLAUDE AVENUE DRAINAGE IMPROVEMENTS PROJECT IN ARABI.

WHEREAS, the Delta Regional Authority Community Infrastructure Fund (DRA CIF) provides direct investment into community-based and regional projects that address the DRA's congressionally mandated infrastructure funding categories (Basic Public Infrastructure and Transportation Infrastructure) and flood control projects; and

WHEREAS, St. Bernard Parish Government has completed a hydrologic and hydraulic analysis of the drainage area along St. Claude Avenue to examine existing drainage patterns and deficiencies; and

WHEREAS, St. Bernard Parish Government has designed a suite of drainage improvements to address deficiencies identified during the hydrologic and hydraulic analysis; and

WHEREAS, St. Bernard Parish Government will leverage approximately \$1.5 million in local funds to request an additional \$2 million in DRA CIF funds to construct the referenced suite of drainage improvements; and

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to develop and submit a DRA CIF application in the amount of \$2 million for the construction of the St. Claude Avenue Drainage Improvements project, and to complete all necessary reports, requirements, assurances, contracts, and any other documents.
