## RESOLUTION SBPC #2394-07-24

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO DEVELOP AND SUBMIT AN APPLICATION FOR LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FUNDING TO ADDRESS ECONOMIC DEVELOPMENT NEEDS AND PROMOTE THE CREATION AND/OR RETENTION OF JOBS AND/OR BUSINESSES IN ST. BERNARD PARISH IN ACCORDANCE WITH THE 2020-2024 STATE OF LOUISIANA CONSOLIDATED PLAN.

**WHEREAS**, the primary objective of the Louisiana Community Development Block Grant (LCDBG) Program is to provide assistance to units of general local government in non-entitlement areas for the development of viable communities by providing a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income; and

**WHEREAS**, the State of Louisiana Consolidated Plan identifies economic development as a high priority and provides funding for activities relative to the creation and/or retention of jobs and/or businesses; and

**WHEREAS**, Glass Half Full, LC3 intends on relocating its existing business to St. Bernard Parish and creating up to one hundred (100) new jobs; and

**WHEREAS**, the LCDBG Program may provide up to \$1 million in financial assistance for the creation of up to one hundred (100) new jobs in St. Bernard Parish; and

**NOW THEREFORE BE IT RESOLVED** the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to develop and submit an LCDBG Program application, and to complete all necessary reports, requirements, assurances, contracts, and any other documents.
