A RESOLUTION RESPECTFULLY REQUESTING THE LOUISIANA DEPARTMENT OF WILDLIFE AND FISHERIES TO APPOINT KIM SERIGNE JR. AS THE NUISANCE WILDLIFE CONTROL OPERATOR AND NUISANCE ALLIGATOR HUNTER FOR ST. BERNARD PARISH.

WHEREAS, Nuisance Wildlife Control Operators are permitted to handle most species except deer, bears, migratory birds, and alligators; and,

WHEREAS, Nuisance Alligator Hunter helps capture and minimize conflicts between alligators and humans; and,

WHEREAS, Kim Serigne Jr. will take any and all required training to become permitted to be a Nuisance Wildlife Control Operator and Nuisance Alligator Hunter.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby respectfully request the Louisiana Department of Wildlife and Fisheries to appoint Kim Serigne Jr as the Nuisance Wildlife Control Operator and Nuisance Alligator Hunter for St. Bernard Parish.


