BERNARD PORT IN THE LAWSUIT ENTITLED "ST. BERNARD PARISH GOVERNMENT V. THE BOARD OF COMMISSIONERS OF THE PORT OF NEW ORLEANS" BEARING DOCKET NUMBER 23-1006 OF THE THIRTY-FOURTH JUDICIAL DISTRICT COURT.

WHEREAS, this document will be introduced and adopted as an Ordinance if used in its official legal capacity.

The Board of Commissioners of the Port of New Orleans" bearing Docket Number 23-1006 of the Thirty-Fourth Judicial District Court.
