On motion of Mr. Moran, seconded by Mrs. Cusimano, it was moved to **table** the following resolution until the August 6, 2024 Council Meeting:

RESOLUTION SBPC #2398-07-24

A RESOLUTION RESPECTFULLY REQUESTING THE ST. BERNARD PARISH COUNCILMEMBERS TO SUPPORT THE RE-ZONING PROCESS OF THE PURCHASED PORT OF NEW ORLEANS PROPERTIES.

WHEREAS, the St Bernard Parish Council, the Governing Authority, intends to protect the health, safety, and wellness of its residents; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, has a vested interest to protect the current Master Plan and the growth patterns that have been established within; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, intends to zone property for the protection of all Residential Districts near and adjacent to land purchased by the Port of New Orleans; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, will make all reasonable attempts to rezone the land for what it has been historically used for; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, will address all undeveloped land as a general zoning change or classification that can be changed at a later date to coincide with our Master Plan; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, wishes to proceed with the rezoning of all lands not directly adjacent to the river for the protection of St. Bernard Parish.

NOW THEREFORE BE IT RESOLVED, the St Bernard Council, the Governing Authority, does hereby support the re-zoning process of the purchased Port of New Orleans properties.


