On motion of Mrs. Mones, seconded by Ms. Meyer, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2407-08-24

A RESOLUTION AUTHORIZING ACCEPTANCE OF A CAPITAL OUTLAY GRANT AWARD IN THE AMOUNT OF \$2,900,000 FROM THE STATE OF LOUISIANA FOR THE ST. BERNARD PARISH FIRE STATION 10, PLANNING AND CONSTRUCTION AND EXECUTION OF A COOPERATIVE ENDEAVOR AGREEMENT TO COMPLETE THE PROJECT.

WHEREAS, the Capital Outlay Act of the State of Louisiana sets out appropriations for projects as provided in the Capital Outlay Budget and approved by the Louisiana State Legislature (Act #5 of the 2024 Regular Session – Capital Outlay Appropriations); and,

WHEREAS, the Omnibus Bond Act of the Louisiana Legislature provides for the issuance of General Obligation Bonds by the State Bond Commission for certain projects contained in the Act as approved by the Louisiana State Legislature; and

WHEREAS, the State has also appropriated State General Fund (Direct) monies and/or other sources of cash for selected projects, or authorized non-cash lines of credit for selected projects, under this program; and,

WHEREAS, St. Bernard Parish Government submitted a request to the Capital Outlay Program for funding to build a new fire station; and,

WHEREAS, the Parish received notice of funding approval under the Capital Outlay Program on July 12, 2024; and,

WHEREAS, the total cost of the project, as currently budgeted, is \$5,679,606.00.

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, does hereby authorize acceptance of funding for the St. Bernard Fire Station 10 as approved by the Capital Outlay Program.
