**WHEREAS**, a vacancy exists on the St. Bernard Fire Protection Districts No. 1-2, Fire Civil Service Board due to the resignation of Lenor Duplessis; and

**WHEREAS**, the Council is desirous of filling the aforementioned vacancy.


