On motion of Mrs. Mones, seconded by Mr. Randall, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2412-09-24

A RESOLUTION REQUESTING NORFOLK SOUTHERN RAILROAD TO TAKE IMMEDIATE ACTION ON CLEANING THE DITCHES FROM ST. CLAUDE AVENUE TO THE FORTY ARPENT CANAL AND FROM POYDRAS TO CAERNARVON IN THE PARISH OF ST. BERNARD, STATE OF LOUISIANA.

WHEREAS, Norfolk Southern Railroad owns drainage ditches running from St. Claude Avenue to the Forty Arpent Canal; and,

WHEREAS, Norfolk Southern Railroad owns drainage ditches running from Poydras to Caernarvon, and,

WHEREAS, the ditch from Goodwill Drive to Massicot Road is partially blocked by a bulkhead after recent railroad tie repairs that is causing water to enter into residents' homes and businesses; and,

WHEREAS, said ditches must be cleaned in order to prevent drainage issues, and;

WHEREAS, it is the responsibility of Norfolk Southern Railroad to dredge said ditches.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority, does hereby respectfully request Norfolk Southern Railroad to take immediate action on cleaning the ditches from St. Claude Avenue to the Forty Arpent Canal and Poydras to Caernarvon in the Parish of St. Bernard, State of Louisiana.
