WHEREAS, a vacancy exists on the St. Bernard Fire Protection Districts No. 1-2, Fire Civil Service Board due to the resignation of Lenor Duplessis; and

WHEREAS, the Council is desirous of filling the aforementioned vacancy.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby appoint **Michael Fernandez Jr.** as St. Bernard Parish Government's Board Member of the St. Bernard Fire Protection Districts No. 1-2, Fire Civil Service Board; and


