On motion of Mr. McCloskey, seconded by Mrs. Mones, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2421-11-24**

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO SUBMIT COMMUNITY DEVELOPMENT BLOCK GRANT - DISASTER RECOVERY RESILIENT COMMUNITIES AND INFRASTRUCTURE PROGRAM (RCIP) APPLICATIONS IN THE AMOUNT OF \$1,958,708 FOR THE VAL REISS TURF REPLACEMENT AND SIDEWALK REPAIRS (\$1,918,708) AND SBPG COMPLEX SIGNAGE (\$40,000) PROJECTS.

**WHEREAS**, the Community Development Block Grant - Disaster Recovery of the State of Louisiana sets out appropriations for projects as provided in the appropriate Community Development Block Grant - Disaster Recovery Action Plans; and,

**WHEREAS**, under the Appropriations Act approved in September 2021, the Department of Housing and Urban Development (HUD) has allocated approximately \$2.3 billion in CDBG-DR funds to the State of Louisiana for ongoing recovery efforts; and

**WHEREAS**, the Louisiana Office of Community Development (OCD) has allocated these CDBG-DR funds to various programs as described in the State of Louisiana Action Plan for the Utilization of Community Development Block Grant Funds in Response to 2020 and 2021 Federal Declarations in Louisiana, as amended; and

**WHEREAS**, OCD has made \$1,958,708.34 in RCIP funding available to St. Bernard Parish as per the notice of funding approval received on November 16, 2023;

**WHEREAS**, St. Bernard Parish Government hosted a community meeting on April 16, 2024 to solicit input regarding the Val Reiss Turf/Sidewalk and SBPG Complex Signage projects and to solicit additional project ideas;

**WHEREAS**, St. Bernard Parish Government selected the two referenced projects based on their merit and degree of urgency; and
