President's Report

From the Desk of Parish President Louis Pomes

December 17, 2024

To St. Bernard Parish Council Members and Residents,

As we gather for the final Parish Council meeting of the year, I would like to take a moment to reflect on the incredible progress we've made together and the joy this holiday season has brought to our community. Serving as your Parish President during this special time of year has been an honor for me, my administration, and my family, reminding us of the true meaning of Christmas: community, generosity, and togetherness.

Capital Projects Update

Our Capital Projects team continues to make excellent progress across St. Bernard Parish:

- At the new Public Library, exterior trim work on glass, curtain walls, and glazing is ongoing, and sidewalks were poured yesterday. The site is being cleaned, interior work continues, and chillers are being tested today.
- At Vista Park, electrical work is wrapping up with wiring to light poles.
- Patricia Park is now complete and ready for the community to enjoy.
- Miscellaneous Drainage projects are progressing well: pipework on Fable is complete, and pipework on E. Genie and Legend is finishing today. Concrete pouring on Legend is mostly done, with crews moving to Fable this week. Preparations for Riverland have begun. Work will pause on December 23 and resume on January 6.
- Old Arabi Drainage: Concrete is being poured on Angela today, with asphalt work starting next week.
- Florida Walk: Equipment mobilization for jack and bore work is planned for this week. Work will pause December 23 and resume January 2.
- Old Arabi Streetscape: The project is nearly complete, with some sod placement planned as needed.

Coastal Restoration Projects

I am proud to announce that two largescale coastal restoration projects have been recommended for CWPPRA funding approval.

- **North Delacroix Marsh Creation and Terracing:** Approved for Phase 2 (construction) funding, this project will create or nourish over 410 acres of marsh near Delacroix at an estimated cost of \$35.5 million.
- **Woodlake Marsh Creation and East Lake Lery Shoreline Protection:** Approved for Phase 1 (engineering/design) funding, these combined projects will enhance our coastal landscape with an estimated cost of \$33.4 million.

Additionally, ongoing projects include:

- **Bayou La Loutre Ridge Restoration:** Under construction.
- **East Delacroix Marsh Creation:** Scheduled to begin construction in Q1 2025.
- **Reggio Marsh Creation:** Expected to begin construction in 2026.

Special thanks to our Federal and State partners, NGOs, private landowners, and Coastal Operations Director John Lane for their support and dedication to these transformative projects.

DOTD Road Striping Updates

- **Project 4400030423:** Preconstruction meeting was held today for a road striping project covering several key routes, including Hopedale Hwy, Florissant Hwy, Bayou Rd, and E Judge Perez. Work is expected to begin January 6th, 2025, and will be completed within 30 days.
- **Future Project:** Plans are underway for restriping W Judge Perez from Norton Avenue to LA 47, with additional concrete patching and surface improvements. Details are still in design.

New Businesses


