From the Desk of St. Bernard Parish President Louis Pomes

While much of the usual construction, roadwork, and updates I would typically report on slowed down over the holidays, we continued to address urgent needs and maintain the systems that keep our parish running smoothly. With that in mind, there are several important updates or items of significance I'd like to report today. New Year's Tragedy in New Orleans:

In response to the tragic events on New Year's Day in New Orleans, St. Bernard Parish partnered with Ochsner Blood Bank to host a mobile blood drive yesterday, on January 6, 2025. I have been deeply moved by the outpouring of support from our community in response to this horrific event. I'm proud and grateful to report that the blood drive was very well attended and a great success. Your willingness to help during such a difficult time demonstrates the strength and compassion of the residents of St. Bernard Parish. Thank you to Councilmember Ryan Randall, who spearheaded this effort, as well as my office staff who assisted with the details. As a community, we can be proud of collaborating to assist our neighbors in Orleans Parish, and hopefully bringing comfort to the victims and families impacted by this tragedy, from many different places and backgrounds.

Louisiana International Terminal (LIT) Update:

In light of ongoing opposition to the Louisiana International Terminal (LIT) project, my office has prepared a document summarizing the process for submitting public comments regarding the U.S. Army Corps of Engineers (USACE) permit application. The comment period for this application will close later this month, on January 14, 2025. To make it easier for residents and business owners to participate, we've included a sample email that can be updated with your personal comments and details. Response Letter:


Community Events:

- Riverbend Force Main — Waiting on permit to go under Violet Canal.
- New Public Library —Curtain walls in place, all exterior glass in place, interior work continues. Finishing up flat roofing. Majority of sidewalks complete this week. Working on landscaping and sprinkler system.
- Patricia Park — Complete
- Vista Park — Lighting for playground complete. Remaining fencing complete. Installed netting on backstops. Finishing up sidewalks and parking this week.
- Misc. Drainage —All pipe work is in place on Fable and Legend. Will pour concrete on Fable this week.
