BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, NOVEMBER 19, 2024 AT THREE O'CLOCK P.M.

On motion of Ms. Meyer, seconded by Mrs. Mones, it was moved to **adopt** the following ordinance:

AN ORDINANCE TO AUTHORIZE ST. BERNARD PARISH GOVERNMENT TO ENTER INTO AN AGREEMENT WITH SUMMIT FIRE & SECURITY TO RESET AND REPLENISH THE FIRE SUPPRESSION SYSTEM LOCATED AT THE MAIN 911 OPERATION CALL CENTER SO AS TO RESUME NORMAL OPERATIONS OF SAME.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, the fire suppression system located at the main 911 Operation Call Center servicing the Parish of St. Bernard was triggered on or about 2:00 a.m. on October 23, 2024; and,

WHEREAS, operations cannot resume at the 911 Operation Call Center until such time as the fire suppression system is reset and replenished; and,

WHEREAS, the inability to resume operations at the 911 Operation Call Center poses an imminent threat of injury to life and property of the residents of the Parish of St. Bernard constituting an emergency pursuant to La. R.S. 38:2211.

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby authorize the Parish President to execute an agreement with Summit Fire & Security to reset and replenish the fire suppression system located at the main 911 Operation Call Center for the Parish of St. Bernard and all other documents necessary to affect the purpose of said agreement.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.
