A RESOLUTION AUTHORIZING SUBMISSION OF A SIGN PERMIT TO LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR A GUIDE IDENTIFICATION SIGN FOR THE MISSISSIPPI RIVER TRAIL VIOLET TRAILHEAD.

WHEREAS, St. Bernard Parish Government has implemented an innovation wayfinding signage system for the bikeway network in St. Bernard Parish that provides a consistent style for identification of routes and access points along Parish bikeways; and

WHEREAS, St. Bernard Parish would like to install a guide identification sign (sample attached) along St. Bernard Highway in Violet to help users identify access to the Mississippi River Trail Violet Trailhead that is consistent with the Parish wayfinding system; and

WHEREAS, the Louisiana Department of Transportation and Development permit process for this sign approval requires that a unanimous resolution passed by the local governing body be included with the permit submission.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council does hereby authorize submission of a permit application to the Louisiana Department of Transportation and Development to provide guidance and identification of the Mississippi River Trail Violet Trailhead.
