On motion of Mr. Randall, seconded by Mr. Everhardt, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2430-01-25**

A RESOLUTION TO OPPOSE PERMIT APPLICATION #MVN-2021-00270-ESG FILED BY THE BOARD OF COMMISSIONERS OF THE PORT OF NEW ORLEANS WITH THE U.S. ARMY CORPS OF ENGINEERS RELATED TO THE LOUISIANA INTERNATIONAL TERMINAL.

**WHEREAS**, on December 16, 2024, the U.S. Army Corps of Engineers issued a "Public Notice" regarding an application submitted by the "Board of Commissioners of the Port of New Orleans" to building a "Wharf and Commercial Shipping Container Terminal on the Mississippi River in St. Bernard Parish," attached hereto as Exhibit A; and,

**WHEREAS**, the Public Notice established a deadline of January 14, 2025 for the submission of any public comments regarding any modifications or objections to the proposed work; and,

**WHEREAS**, the St. Bernard Parish Council desires to express its opposition to all of the relevant permitting authorities, including, but not limited to, the U.S. Army Corps of Engineers, the State of Louisiana, and its various agencies; and,

**WHEREAS**, the St. Bernard Parish Council desires to request an extension of the public comment period due to the timing of the issuance of the Public Notice that resulted in a comment period covering multiple holiday periods that have limited the opportunity for a full response from the community; and,

**WHEREAS**, the St. Bernard Parish Council desires to request that the U.S. Army Corps of Engineers hold a public hearing regarding the consideration of application #MVN-2021-00270-ESG for the reasons noted herein; and,

**WHEREAS**, the consideration of the various viewpoints would assist the U.S. Army Corps of Engineers in fully understanding the magnitude of the adverse impact of the proposed Louisiana International Terminal facility.

**NOW THEREFORE BE IT RESOLVED**, that the St. Bernard Parish Council, the Governing Authority, does hereby express its firm opposition to the Louisiana International Terminal for the following, non-exclusive, reasons:


