## **RESOLUTION SBPC #2432-01-25**

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO COMPLETE AND SUBMIT THOSE DOCUMENTS AND AGREEMENTS REQUIRED IN CONNECTION WITH THE COMMUNITY WATER ENRICHMENT FUND (CWEF) 2024-2025 GRANT APPLICATION IN THE SUM OF \$350,000.00 TO THE STATE OF LOUISIANA TO INSTALL NEW 24-INCH DIAMETER POTABLE WATER PIPING AND VALVES ASSOCIATED WITH THE NEW HIGH SERVICE WATER DISTRIBUTION PUMP FOR THE PURPOSE OF IMPROVING DRINKING WATER QUALITY FOR THE RESIDENTS OF ST. BERNARD PARISH.

**WHEREAS**, the Public Works Department is responsible to provide safe drinking water and fire protection to the residents of St. Bernard Parish; and,

**WHEREAS**, there is a need for the Public Works Department to install new 24-inch diameter potable water piping and valves associated with the new high service water distribution pump and,

**WHEREAS**, the purpose of CWEF is to assist local governments with grant funding, with no match or reimbursement required from the recipient or Parish, for rehabilitation, improvement, and construction projects on community water systems for eligible Parishes in the amount of \$350,000.00; and,

**WHEREAS**, the grant will allow the Parish to use the grant in the amount of \$350,000.00 to install new 24-inch diameter potable water piping and valves associated with the new high service water distribution pump.
