- **Our Lady of Prompt Succor's Tomato Festival:** April 25-27, 2025



PRESIDENT'S REPORT

February 18, 2025

Public Works and Road Yard Update

- **Jean Lafitte (Chalmette):** Emergency drain line repair at the crossover heading north from Judge Perez.
- **Charles Drive at Florida Avenue (Chalmette):** Replaced 60 feet of 20-inch drain line and installed 30 feet of 30-inch drain line for outfall.
- **Meraux Lane (Violet):** Replaced 130 feet of 24-inch drain line and installed 30 feet of 30-inch drain line in the outfall.
- **Meraux Lane (Upcoming):** Emergency repair of 440 feet of drain line, south of 40 Arpent.
- **Blanchard Drive (Chalmette):** Repaired approximately 60 feet of sidewalk.
- **6410 Jules Brown (Violet):** Single-family residential demolition completed.
- **2909 Stacy Drive (Violet):** residential demolition in progress.
- Other concrete pours will be completed this week in locations throughout the Parish, and will be included in my next report.
