## President's Report

**Tuesday, April 1, 2025**

### To the Honorable Council Members and Esteemed Residents of St. Bernard Parish,

I hope this report finds each of you well as we move into April with a renewed sense of community and purpose. As always, I remain committed to transparency, safety, and celebrating the people and progress that make our parish a place we're proud to call home.

First, a brief overview of a recent situation, to clarify the details and our emergency response. On Friday, March 21, a subcontractor conducting permitted telecommunications work damaged a natural gas pipeline near Jacob Drive and East Genie Street in Chalmette. This resulted in a gas leak that prompted a multi-agency emergency response. Our Fire Department was on scene within two minutes, supported by the Sheriff's Office, Animal Control, and additional parish personnel. We thank Atmos Energy, Hazmat crews, and all who helped restore safety and gas service to the area quickly and professionally. This incident serves as an important reminder to always call 811 before digging to help prevent similar incidents. Thank you again to our first responders and residents for your cooperation during this emergency.

We'd also like to recognize the 50th Annual Louisiana Crawfish Festival, which was a tremendous success. Thousands of residents and visitors came out to enjoy live music, crawfish races, rides, and incredible food at the Civic Center grounds. Events like these highlight the strong cultural spirit of our parish and the importance of continuing traditions that bring us all together.
