To the Honorable St. Bernard Parish Councilmembers and Residents,

St. Bernard Parish Government remains focused on preparing for both the expected and the unexpected. I want to take a moment to highlight recent activity across our community.

Drainage upgrades continue across several neighborhoods to reduce flood risk, improve flow, and modernize aging systems. In addition to new underground drainage lines, brick manholes are being installed to improve long-term access for maintenance and inspection. ADA-accessible sidewalk construction remains underway along portions of Judge Perez Drive in Violet. Funded through DOTD and the Federal Highway Administration's Vulnerable Road User Program, this project enhances safety and ensures compliance with the Americans with Disabilities Act.

Last week, our Office of Homeland Security and Emergency Preparedness held its annual Critical Needs Transportation Exercise. This evacuation drill helps ensure we're ready to safely assist residents with special needs and non-English speakers in the event of a mandatory evacuation. Thank you to the parish employees, volunteers, and partners who made it a success.

We're also pleased to announce the completion of the mixed-use path along Jean Lafitte Parkway. This new ten-foot-wide trail connects directly to the 40 Arpent Trail, providing a safe, convenient route for walkers and bikers. This federally funded project reflects our commitment to sustainable infrastructure and active transportation.

On May 28, we proudly participated in **St. Bernard Day at the Capitol**, where residents, leaders, and businesses gathered in Baton Rouge to highlight our parish and advocate for its priorities. Events like this keep our voice strong at the state level. Thank you to everyone who helped make it a success.

We'd also like to welcome and congratulate the following local businesses that received or renewed permits since our last report: **Classy Chaos Boutique, Tee's Pineapple Express, Kind Health and Wellness, A+ Tech Wireless & Computer, David A.
