# **Letter to User**

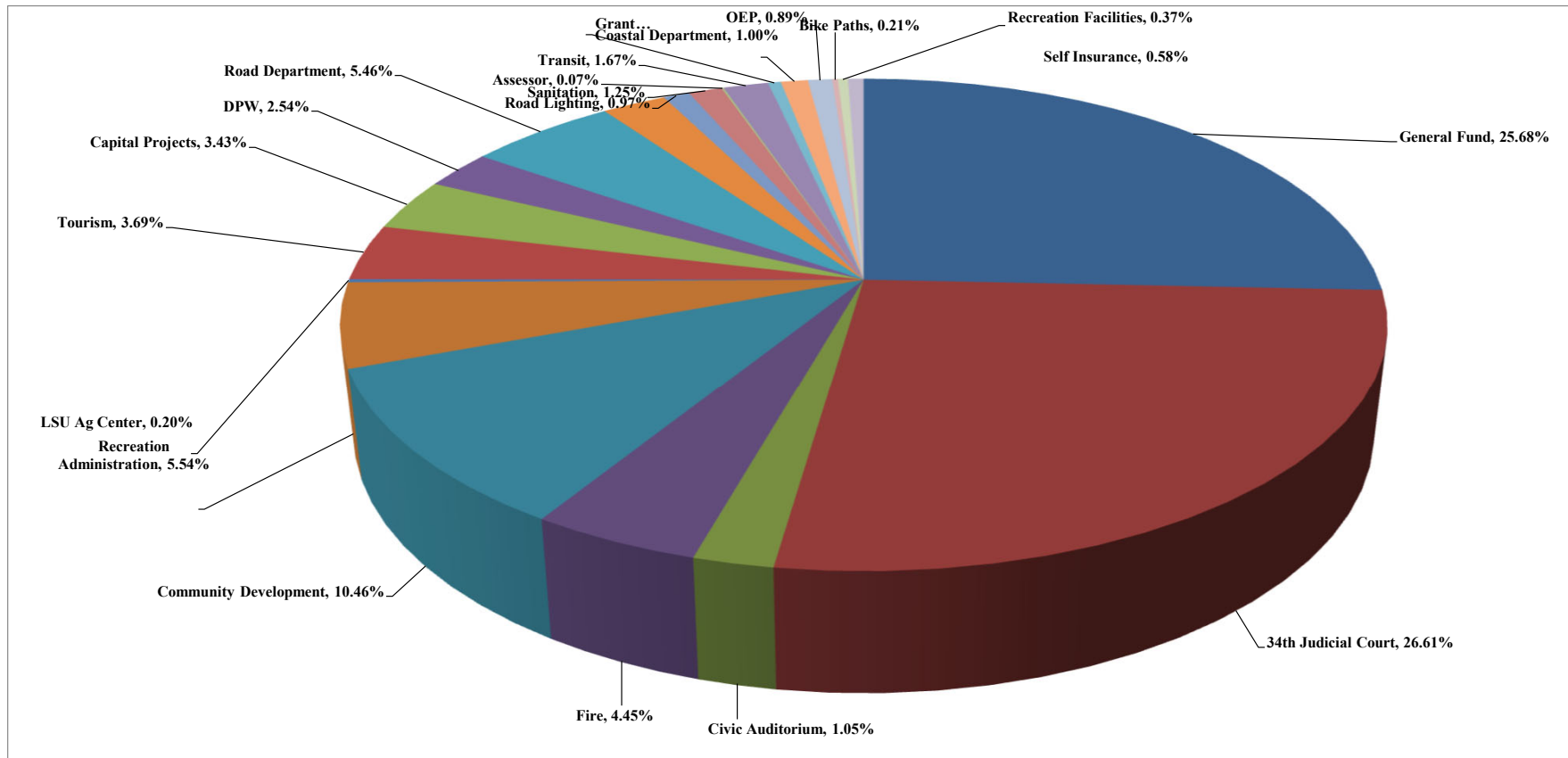
**Included with this report are the financial statements for May 2025. As disclosed in the report, during May 2025 the Parish operated well within its allowable budget parameters with regards to operational expenditures. The optimum level of monthly expenditures as a percentage of budgeted expenditures through May is 41.65%. The overall rate within the General Fund of actual expenditures, as a percentage through May 2025, is 30.71% which results in a favorable variance of 10.94% below budgeted amounts. The Parish will continuously monitor the budget in an effort to maximize revenues while also finding ways to become more efficient.**

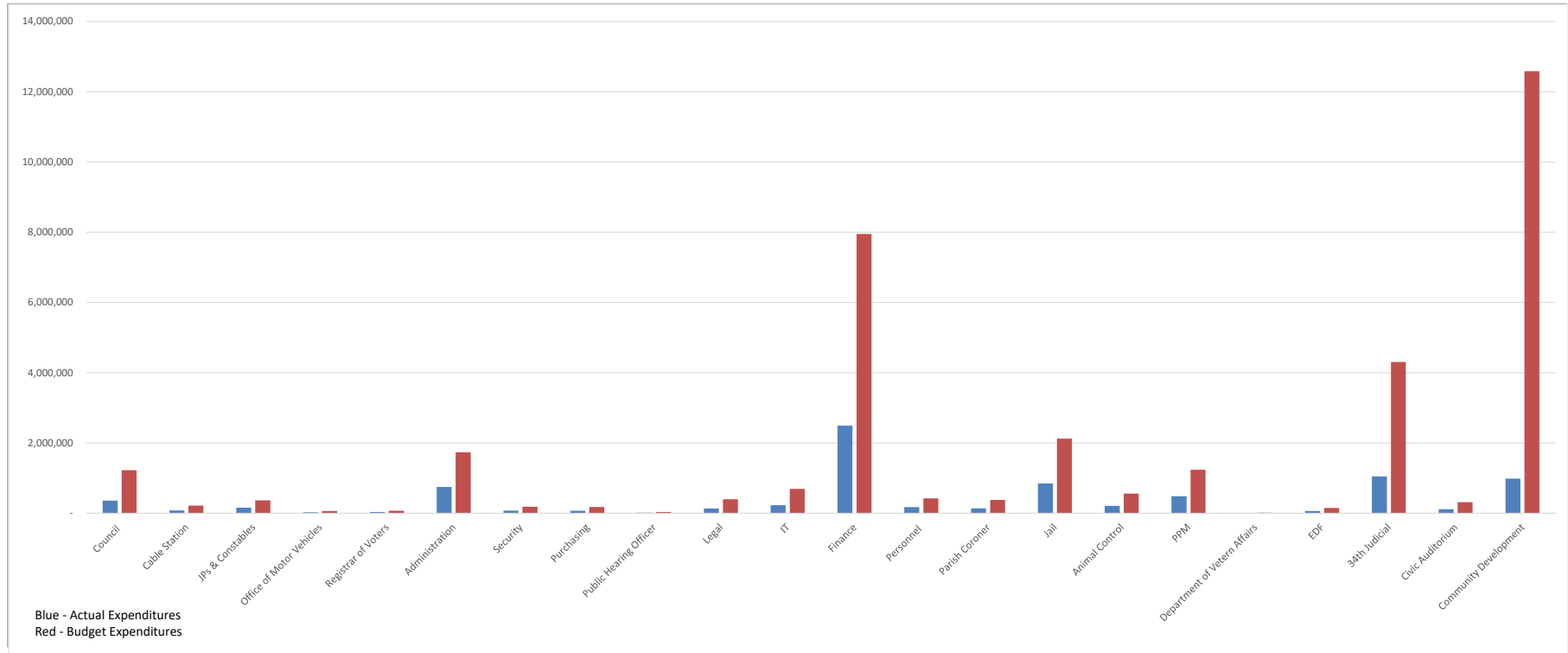
