WHEREAS, Henry Rodriguez, Jr. served as Parish President of St. Bernard Parish from 2004 through 2008; and,

WHEREAS, Lynn B. Dean represented District 10 in Eastern St. Bernard Parish from 1981 through 1991 on the St. Bernard Parish School Board, and;

WHEREAS, Lynn b. Dean served as Parish President of St. Bernard Parish from 1992 through 1996; and,

WHEREAS, Lynn B. Dean served as State Senator for District 1 from 1996 through 2004; and,

WHEREAS, Lynn B. Dean served as Councilman at Large – East from 2004 through 2008.


The Council Chair, Mr. McCloskey, cast his vote as **YEA**.
