A RESOLUTION TO ESTABLISH PROCEDURES FOR ELECTRONIC RECORDING DEVICE USE DURING EXECUTIVE SESSION AND THE DISSEMINATION OF INFORMATION DISCUSSED IN EXECUTIVE SESSION.

WHEREAS, the council, the governing authority of St. Bernard Parish, is desirous to create rules governing the use of electronic recording devices during executive session and the dissemination of information discussed in executive session;

THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, the Governing authority hereby establishes the following rules governing Executive Sessions at meetings of the St. Bernard Parish Council:

1. All electronic recording devices, including but not limited to cell phones, shall be placed in the custody of the Clerk of Council prior to entering into Executive Session and the use of any such device shall be prohibited during Executive Session; and
2. All information discussed in executive session is considered confidential and shall not be disseminated to any third party without approval of a majority of the sitting members of the St. Bernard Parish Council, which approval shall be memorialized in a resolution.


The Council Chair, Mr. McCloskey, cast his vote as **YEA**.
