On motion of Ms. Meyer, seconded by Mr. Moran, it was moved to **adopt** the following resolution:

## RESOLUTION SBPC #2461-06-25

A RESOLUTION AUTHORIZING THE USE OF EXPENDITURE CODE 1002010-520012-4251 – “LIT TERMINAL LITIGATION” FOR COSTS ASSOCIATED WITH COMMENTING UPON, OR LITIGATING AGAINST, THE CONCURRENT PROJECT REFERENCED AS THE “INDUSTRIAL LOCK REPLACEMENT PROJECT”

**WHEREAS**, the council, the governing authority of St. Bernard Parish, in its Ordinance SBPC #2642-03-25 established an expenditure code within the St. Bernard Parish Government council budget for legal actions and defense against the Louisiana International Terminal (“LIT”) project and to provide for related matters; and,

**WHEREAS**, the U.S. Army Corps of Engineers has opened a public comment period for the project references as the “Industrial Lock Replacement Project”; and,

**WHEREAS**, the Industrial Lock Replacement Project is a project running concurrent with the LIT project and is thus related to, and has significant impact upon, St. Bernard Parish Government’s opposition to the LIT project.

**THEREFORE BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority hereby authorize the use of expenditure code 1002010-520012-4251 – “LIT Terminal Litigation” for all costs incurred in submitting public comments to the Industrial Lock Replacement Project and any litigation costs which might result from any ultimate permit issued with respect to that project.
