On motion of Mr. Everhardt, seconded by Ms. Meyer, it was moved to **remove** the following resolution:

RESOLUTION SBPC #2462-06-25

A RESOLUTION DIRECTING THE PARISH PRESIDENT TO TERMINATE ANY AND ALL PROFESSIONAL SERVICE CONTRACTS WITH ADAMS AND REESE FOR THE PROVISION OF LOBBYING SERVICES.

WHEREAS, it has come to the attention of the St. Bernard Parish Council, the governing authority, that Adams and Reese represent the Port of New Orleans with respect to the development of the Louisiana International Terminal; and,

WHEREAS, the St. Bernard Parish Council, the governing authority, finds that it is a conflict of interest for Adams and Reese to have represented St. Bernard Parish Government while also representing the Port of New Orleans related to the Louisiana International Terminal; and,

WHEREAS, the development of the Louisiana International Terminal is materially averse to the interest of the residents of St. Bernard Parish; and,

WHEREAS, the continued engagement of Adams and Reese is contrary to the interests of the residents of St. Bernard Parish.

NOW THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, hereby directs the Parish President to terminate any and all current professional service contracts with Adams and Reese for the provision of lobbying services.

BE IT FURTHER RESOLVED, that the Parish President is hereby directed to recover all funds paid to Adams and Reese for lobbying services.
