A RESOLUTION REQUESTING THE ST. BERNARD PARISH DISTRICT ATTORNEY'S OFFICE RE-ENROLL AS CO-COUNSEL FOR ST. BERNARD PARISH GOVERNMENT IN THE MATTER CAPTIONED "ST. BERNARD PARISH GOVERNMENT V. BOARD OF COMMISSIONERS FOR THE PORT OF NEW ORLEANS" CIVIL NO. 23-1006, 34th JUDICIAL DISTRICT COURT FOR THE STATE OF LOUISIANA.

WHEREAS, the council, the governing authority of St. Bernard Parish, on November 19, 2024, adopted its Ordinance SBPC #2619-11-24 requesting the St. Bernard Parish District Attorney's Office re-enroll in the matter captioned "St. Bernard Parish Government v. Board of Commissioners for the Port of New Orleans" Civil No. 23-1006, 34th Judicial District Court for the State of Louisiana (the "Lawsuit") and the council is still desirous that the St. Bernard Parish District Attorney's Office re-enroll in said Lawsuit as co-counsel for St. Bernard Parish Government;

THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority hereby again respectfully requests that the St. Bernard Parish District Attorney's Office re-enroll as co-counsel of record in the Lawsuit on behalf of St. Bernard Parish Government.
