AN ORDINANCE TO AUTHORIZE THE RETENTION OF THE LAW FIRM MCGLINCHY STAFFORD PLLC TO PROVIDE LEGAL REPRESENTATION AND LEGAL SERVICES TO ST. BERNARD PARISH GOVERNMENT FOR LITIGATION AS IT PERTAINS TO THE MATTER CAPTIONED "ST. BERNARD PARISH GOVERNMENT v. BOARD OF COMMISSIONERS FOR THE PORT OF NEW ORLEANS" CIVIL NO. 23-1006, 34<sup>TH</sup> JUDICIAL DISTRICT COURT FOR THE STATE OF LOUISIANA AND ANY RELATED MATTERS.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the employment of the Law Firm of McGlinchey Stafford PLLC ("Law Firm") to provide legal representation and legal services to St. Bernard Parish Government for litigation as it pertains to the matter captioned "St. Bernard Parish Government v. Board of Commissioners for the Port of New Orleans" Civil No. 23-1006, 34<sup>TH</sup> Judicial District Court for the State of Louisiana.

**SECTION 2.** Compensation. The Law Firm shall be compensated pursuant to the Louisiana Attorney General rates set forth in the attached "Exhibit A".

**SECTION 3.** The Parish President is hereby authorized to enter into a contract for legal services with the Law Firm in accordance with section 4-02 (b) of the Home Rule Charter.

**SECTION 4.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.





Pursuant to the authority of the Attorney General to supervise the representation of the state's interests, to ensure qualifications of counsel, and to exercise oversight over legal counsel for the state as granted in La R.S. 42:257, 258, and 262, this is to advise all interested persons that the approved Maximum Hourly Fee Schedule of this office for professional legal services, effective this date, shall be as follows:

\$350.00	PER HOUR FOR ATTORNEYS HAVING EXPERIENCE OF TEN YEARS OR MORE IN THE PRACTICE OF LAW
\$275.00	PER HOUR FOR ATTORNEYS HAVING EXPERIENCE OF FIVE TO TEN YEARS IN THE PRACTICE OF LAW
\$225.00	PER HOUR FOR ATTORNEYS HAVING EXPERIENCE OF THREE TO FIVE YEARS IN THE PRACTICE OF LAW
\$175.00	PER HOUR FOR ATTORNEY HAVING EXPERIENCE OF LESS THAN THREE YEARS IN THE PRACTICE OF LAW
\$80.00	PER HOUR FOR PARALEGAL SERVICES
