BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, JULY 15, 2025 AT THREE O'CLOCK P.M.

On motion of Mrs. Cusimano, seconded by Mr. Moran, it was moved to **adopt** the following ordinance:

## **ORDINANCE SBPC #2665-07-25**

### **Summary No. 4277**

Introduced by: Administration on 7/1/25  
Public Hearing held on 7/15/25

AN ORDINANCE TO DECLARE A CERTAIN PARCEL OF LAND SITUATED IN SECTION 10, TOWNSHIP 12 SOUTH, RANGE 13 EAST AND SECTION 75, TOWNSHIP 12 SOUTH, RANGE 12 EAST, SOUTHEASTERN LAND DISTRICT EAST OF THE MISSISSIPPI RIVER AS SURPLUS, TO DONATE THE PROPERTY TO THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, AND TO AUTHORIZE THE PARISH PRESIDENT TO EXECUTE ALL NECESSARY DOCUMENTS.

**WHEREAS**, St. Bernard Parish Government ("SBPG") considers this property surplus and it is not needed for a public purpose of the Parish; and,

**WHEREAS**, the Louisiana Department of Transportation and Development requires said property in order to complete an upcoming sidewalk enhancement project in the Parish of St. Bernard; and,

**WHEREAS**, said sidewalk enhancement project will benefit the residents of the Parish of St. Bernard by providing safer pedestrian paths along a major thoroughfare.

### **ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:**

**SECTION 1.** The Property is fully described in Exhibit "A", the Act of Donation, attached hereto. This property will be referred to hereinafter in this ordinance as "THE PROPERTY".

**SECTION 2.** The St. Bernard Parish Council hereby authorizes the Parish President to donate THE PROPERTY to the Louisiana Department of Transportation and Development and to execute any necessary documents for the donation.

**SECTION 3.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 4.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.



Judge Perez Dr., Chalmette, LA 70043, herein represented by Louis Pomes, its Parish President, duly authorized to appear herein as per Ordinance SBPC# \_\_\_\_\_, dated \_\_\_\_\_, a copy of which is attached hereto and made a part hereof; and THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT OF THE STATE OF LOUISIANA, Donee, whose permanent mailing address is Post Office Box 94245, Baton Rouge, Louisiana 70804, herein represented by CHARLES MCBRIDE, authorized by Policy and Procedure Memorandum Number 5, dated December 16, 1976, as amended, issued by the Secretary of the Louisiana Department of Transportation and Development, who accepts this donation on behalf of the Department of Transportation and Development, the following described property, situated in the Parish of St. Bernard, Louisiana:

Donor declared that it does by these presents, donate, convey, assign, grant, transfer, set over and deliver, with all legal warranties and with full substitution and subrogation, to all rights and actions of warranty against all former owners and vendors, to Donee, accepting for itself and its successors and assigns, and acknowledging due delivery and possession thereof the following described property:

## DESCRIPTION

One (1) certain tract or parcel of land, together with all the improvements situated thereon, and all of the rights, ways, privileges, servitudes and advantages thereunto belonging or in anywise appertaining, situated in Section 10, Township 12 South, Range 13 East, and Section 75, Township 12 South, Range 12 East, Southeastern Land District East of the Mississippi River, St. Bernard Parish, Louisiana, identified as PARCEL NO. 2-1 as shown on Sheet Nos. 2 and 3, on the property map for STATE PROJECT NO. H.014643, LA 39: W. JUDGE PEREZ DR. IMPROVEMENTS, ST. BERNARD PARISH, LOUISIANA, prepared by John S. Teegarden, professional land surveyor, dated August 19, 2024, said map being attached hereto and made a part hereof, which property is more particularly described as follows:

There is specifically included in this present donation and conveyance all of the improvements situated wholly or partially on the property together with the appurtenances thereto.

This donation is made for and in consideration of the mutual benefits accruing to the parties hereto.

Donor acknowledges and agrees that the consideration provided herein constitutes full and final settlement for the property hereby donated and for any and all diminution in value of the Donor's remaining property as a result of the transfer of this property for highway purposes.

All ad valorem taxes assessed against the above described property for the four (4) years immediately preceding the current year have been paid. Taxes for the current year will be prorated in accordance with the provisions of Act No. 123 of the Legislature of the State of Louisiana for the year 1954.

It is understood and agreed that Donor reserves unto itself, its successors and assigns, all oil and gas minerals beneath the areas hereinabove described. It is specifically understood, however, that while no exploration, drilling, nor mining of oil or gas minerals of any kind shall be conducted upon said area, there may be directional drilling from adjacent lands to extract the oil or gas minerals from under said area.

It is expressly agreed and understood that Donor has been afforded the right and opportunity to have this property appraised and has been afforded the right and opportunity to receive just compensation for such property, and that Donor has elected to forego, waive and extinguish such rights and opportunities in favor of this donation to the Donee.

The consideration recited herein represents full and final settlement of all claims of any kind to the full extent of Donor's loss, except relocation assistance claims where applicable, and specifically represents a compromise by all parties to avoid formal expropriation proceedings and the added expense of litigation.
