AN ORDINANCE TO AUTHORIZE ENTRY INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH THE LAKE BORGNE BASIN LEVEE DISTRICT RELATIVE TO HOUSING PERSONNEL DURING SEVERE WEATHER EVENTS.

WHEREAS, in accordance with Section 14(C) of Article VII of the Constitution of Louisiana, the Lake Borgne Basin Levee District (the "District") and St. Bernard Parish Government (the "Parish") wish to enter into a Cooperative Endeavor Agreement relative to the housing of District personnel during severe weather events.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council hereby authorizes the Parish President to execute the Cooperative Endeavor Agreement attached hereto delineating each party's obligations with respect to the housing of District personnel during severe weather events.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon the authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph provision or portion of this Ordinance, the St. Bernard Parish Council hereby expressing and declaring that it would have adopted the remaining portion(s) of this Ordinance with the invalid portion(s) omitted.



**COOPERATIVE ENDEAVOR AGREEMENT BETWEEN
ST. BERNARD PARISH GOVERNMENT AND THE
LAKE BORGNE BASIN LEVEE DISTRICT**

This Cooperative Endeavor Agreement (the “Agreement”) is entered into by and between St. Bernard Parish Government (“SBPG”) and the Lake Borgne Basin Levee District (the “District”), through its governing authority, the Southeast Louisiana Flood Protection Authority – East (“FPA”), on this _____ day of _____, 2025.

RECITALS

WHEREAS, each of the parties to this Agreement are a political subdivision of the State of Louisiana; and

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides, in pertinent part, that “for a public purpose the State and its political subdivisions or political corporations may engage in cooperative endeavors with each other or with any public or private association, corporation or individual”; and

WHEREAS, the District is responsible for responding to flood flight activities and damage assessments after storms and hurricanes; and

WHEREAS, the District does not currently own an adequately hardened structure in St. Bernard Parish to safely house levee district personnel during severe tropical storms or hurricanes; and

WHEREAS, SBPG does own adequately hardened structures in St. Bernard Parish to house levee district personnel during severe tropical storms or hurricanes; and

WHEREAS, it is beneficial for the residents of St. Bernard Parish for there to be a rapid response for the activities referenced above by the District following severe tropical storms or hurricanes.

NOW, THEREFORE, the parties hereto agree as follows:

HOUSING OF DISTRICT PERSONNEL

SBPG agrees to identify and provide a reasonably safe location to house a reasonable number of District personnel during declared emergencies such as severe weather events, including but not limited to tropical storms and hurricanes.

The District shall be responsible for providing its personnel with all equipment and supplies necessary to perform their function. The District shall further immediately provide SBPG with the number, and identity, of the personnel for which it seeks housing during severe weather events.

HOLD HARMLESS AND INDEMNITY

To the extent permitted by the laws of the State of Louisiana, the District agrees and obligates itself, its successors and assigns, to defend, indemnify and hold harmless SBPG and its officials, officers, commissioners and employees against any and all liabilities, claims, demands, suits, and legal actions, under any theory of law, asserted by or in favor of any person, including but not limited to, claims for loss of life or injury or damage to persons or property or any of the above, which might arise from the housing of District personnel pursuant to this Agreement or the performance of said personnel's work; provided, however, that any injury, loss or damage found by a court of competent jurisdiction, all appeals having been exhausted, to have been caused solely by the gross negligence or willful misconduct of SBPG shall be excluded from this indemnity.

CHOICE OF LAW, VENUE AND ATTORNEY FEES

This Agreement shall be governed by Louisiana law and the provisions of this Agreement shall be enforced by, and any legal action must be instituted in, a court of competent jurisdiction for the Parish of St. Bernard. If it is necessary for SBPG to file a lawsuit to enforce the provisions of this Agreement, the District agrees to pay the attorney's fees of SBPG and court costs in

accordance with its ultimate liability, if any, which may be determined. If SBPG shall, without fault on its part, be made a party to any claim or litigation commenced by or against the District arising out of the obligations established in this Agreement, the District shall pay all costs and attorney's fees incurred by SBPG in connection therewith.
