A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO SUBMIT A PROPOSAL TO THE NATIONAL FISH AND WILDLIFE FOUNDATION COASTAL RESILIENCE FUND FOR THE PURPOSE OF SECURING FUNDING TO UPDATE THE PARISH'S COASTAL STRATEGY DOCUMENT.

WHEREAS, the National Fish and Wildlife Foundation (NFWF) administers the Coastal Resilience Fund (CRF) program and provides funding for planning activities relative to fish and wildlife habitat and flood risk reduction; and,

WHEREAS, St. Bernard Parish Government has maintained the Coastal Strategy Document, a comprehensive local coastal restoration plan, since 2016 and has updated the plan in 2018 and 2022; and,

WHEREAS, St. Bernard Parish Government now has an interest in updating the Coastal Strategy Document in 2026 to reflect current priorities and future aspirations.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council does hereby authorize the parish president to submit a proposal to NFWF requesting \$250,000 from the CRF for the purpose of updating the Coastal Strategy Document.


