BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 19, 2025 AT THREE O'CLOCK P.M.

On motion of Ms. Meyer, seconded by Mrs. Mones, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2482-08-25**

A RESOLUTION AUTHORIZING THE ST. BERNARD PARISH COUNCIL TO APPROVE A REVISION TO THE HOUSING CHOICE VOUCHER PROGRAM ADMINISTRATIVE PLAN TO ESTABLISH A WAITING LIST PREFERENCE FOR FAMILIES IN THE EMERGENCY HOUSING VOUCHER PROGRAM WHO ARE TRANSITIONING TO THE HOUSING CHOICE VOUCHER PROGRAM.

**WHEREAS**, the St. Bernard Parish Government (SBPG) Housing and Redevelopment Department is an entity of SBPG that serves St. Bernard Parish residents through the Housing Choice Voucher Program (HCVP), Low-Income Home Energy Assistance Program (LIHEAP), and Community Services Block Grant (CSBG); and,

**WHEREAS**, SBPG Housing and Redevelopment Department was awarded funding for the Emergency Housing Voucher (EHV) Program by the United States Housing and Urban Development (HUD); and

**WHEREAS**, EHVs are tenant-based vouchers limited to individuals and families who are (1) homeless; (2) at risk of homelessness; (3) fleeing, or attempting to flee, domestic violence, sexual assault, stalking, or human trafficking; or (4) recently homeless and for whom providing rental assistance will prevent the family's homelessness or having high risk of housing instability; and

**WHEREAS**, funding for EHV is expected to end in 2026 and HUD is encouraging Public Housing Agencies to consider transitioning EHV families to HCVP so that EHV families do not lose assistance and potentially face homelessness; and

**WHEREAS**, SBPG Housing and Redevelopment Department currently has nine EHV families; and

**ABSENT:** None


The Council Chair, Mr. McCloskey, cast his vote as **YEA**.
