On motion of Mr. Moran, seconded by Ms. Meyer, it was moved to **adopt** the following resolution:

A RESOLUTION RESPECTFULLY REQUESTING ST. BERNARD PARISH GOVERNMENT TO PARTNER WITH "SAVE OUR ST. BERNARD" TO DIGITIZE AND PRESERVE ITS PETITION REGARDING THE LOUISIANA INTERNATIONAL TERMINAL PROJECT, INCLUDING THE USE OF COOPERATIVE ENDEAVOR AGREEMENTS AND OTHER RESOURCES NECESSARY TO FACILITATE ACCESSIBILITY AND TRANSMITTAL TO LOCAL, STATE, AND FEDERAL LEADERS.

WHEREAS, the nonprofit organization "Save Our St. Bernard" (SOS) has collected a petition of thousands of signatures in opposition to the Louisiana International Terminal (LIT) project in Violet, demonstrating significant community concern; and,

WHEREAS, SOS has stated its intent to make this petition available to local, state, and federal leaders, so that the voices of St. Bernard Parish residents are fully considered in decisions affecting the future of the Parish; and,

WHEREAS, the St. Bernard Parish Council recognizes the importance of ensuring that citizen-led petitions are preserved, accessible, and efficiently transmitted to decision makers; and,

WHEREAS, digitizing the petition will enhance accessibility, create a permanent public record, and allow for efficient sharing with leaders and agencies; and,

WHEREAS, it is in the interest of the Parish Government to provide resources, including the drafting of Cooperative Endeavor Agreements (CEAs) or other necessary arrangements, to accommodate the digitization and preservation of the petition in partnership with SOS; and,

WHEREAS, it is the intent of the St. Bernard Parish Council to submit this resolution to the SOS organization as a request to start the digitization of the SOS petition and signatures.
