RESOLUTION SBPC #2490-10-25

A RESOLUTION AUTHORIZING THE ST. BERNARD PARISH COUNCIL TO ADOPT AND APPROVE REVISIONS TO THE HOUSING CHOICE VOUCHER PROGRAM ADMINISTRATIVE PLAN.

WHEREAS, HUD requires all public housing agencies to develop a Housing Choice Voucher Program Administrative Plan that includes local policies for administering the program in a manner that is consistent with HUD requirements and the local goals and objectives as set forth in the public housing agency's Agency Plan; and,

WHEREAS, PHAs must revise their Administrative Plans in accordance with statutory, regulatory, and administrative policies; and,

WHEREAS, there have been several policy changes necessitated by the Housing Opportunity Through Modernization Act of 2016 (HOTMA), other regulations, and HUD Public and Indian Housing Notices; and,

WHEREAS, St. Bernard Parish Government Housing and Redevelopment is revising its Administrative Plans to incorporate such policy changes.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, acting as governing authority of St. Bernard Government Housing and Redevelopment, does hereby adopt and approve the revised Housing Choice Voucher Program Administrative Plan with an effective date of November 1, 2025.
