On motion of Mrs. Cusimano, seconded by Ms. Meyer, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2493-10-25

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN ST. BERNARD PARISH GOVERNMENT AND THE OLD ARABI NEIGHBORHOOD ASSOCIATION IN REGARD TO THE AYCOCK STREET BARN.

WHEREAS, it is the intention of the St. Bernard Parish Government to enter into the Memorandum of Understanding in connection with the Aycock Street Barn, and;

WHEREAS, St. Bernard Parish President Louis Pomes, is hereby authorized and directed to do, or cause to be done, all such acts and things and to execute and deliver or cause to be executed Memorandum of Understanding (as attached in Exhibit "A"), in the name of and on behalf of St. Bernard Parish Government, as they may deem necessary or appropriate to carry out the intent of the foregoing resolution.

NOW, THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority, does hereby authorize Parish President Louis Pomes to sign and to execute the Memorandum of Understanding regarding the use of the Aycock Street Barn by the Old Arabi Neighborhood Association.

BE IT FURTHER RESOLVED that if any section, clause, paragraph, provision or portion of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Resolution with the invalid portions omitted.



MEMORANDUM OF UNDERSTANDING
By and Between
ST. BERNARD PARISH GOVERNMENT
and
OLD ARABI NEIGHBORHOOD ASSOCIATION

THIS ____ DAY OF _____, 2025 appeared *ST. BERNARD PARISH GOVERNMENT* represented by its president, the *Honorable Louis Pommès*, and the *OLD ARABI NEIGHBORHOOD ASSOCIATION*, represented by its president, *Gay Parvazi*, who forthwith mutually agree to the following terms and conditions relative to the use of the Aycock Street Barn:

Whereas, *St. Bernard Parish Government* (hereinafter *Parish Government*) owns the facility designated as the Aycock Street Barn, located at 409 Aycock Street, Arabi, Louisiana and has established the facility as the St. Bernard Parish Tourist Welcome Center under the daily administration of the St. Bernard Parish Department of Tourism; and

Whereas, the *Old Arabi Neighborhood Association* (hereinafter *OANA*) is a non-profit corporation domiciled in the Parish of St. Bernard organized according to the laws governing non-profit corporations in the State of Louisiana; and

Whereas, the *OANA* has partnered with *Parish Government* in the development and preservation of the Old Arabi Neighborhood; and

Whereas, the *OANA* regularly sponsors community programs which enhance the quality of life in the Old Arabi Neighborhood, including but not limited to maintaining the landscaping and beautification projects at the Aycock Barn and the Old Jail; decorating the median on St. Bernard Hwy for the Christmas Season; contributing art work for the barn; and maintaining the little free library that is located outside the Old Jail. They use their own funds and manpower for these projects.

ARTICLE I

Parish Government agrees to:

1. Allow the Aycock Street Barn to be utilized by the *OANA* for "Sippin in the Sunset" and the Sugar Fest. Both events enhance the quality of life in Old Arabi and the Parish of St. Bernard.
2. Use *Parish Government* personnel to open and close the facility for events hosted by the *Arabi Association*.
3. Physically maintain the Aycock Street Barn making available exterior and interior spaces including restrooms for use by the *OANA* during scheduled events.
4. Provide use of the Aycock Street Barn on a first come first serve basis.

ARTICLE II

OANA agrees to:

1. Produce a certificate of insurance. Schedule use of the Aycock Street Barn through the St. Bernard Parish Department of Tourism.

2. Designate the president of the Arabi Association as the official representative of the organization, responsible for scheduling use of the Aycock Street Barn in writing.

ARTICLE III

1. This agreement will become effective upon the date of acceptance by the St. Bernard Parish President.
2. The program conducted under this agreement will be reviewed annually by Parish Government, through the Department of Tourism and the Arabi Association for the purpose of evaluating its effectiveness and desirability of its continuation.

ARTICLE IV

1. This agreement may be terminated in whole or in part on ninety (90) days written notice by either party to the agreement.
2. Nothing herein shall be construed as obligating *Parish Government* or the *OANA* to expend funds or as involving either in any contract or other obligation for the future payment of money unless specifically provided for herein by contract.

ARTICLE V

1. Arabi Association agrees to protect, defend, indemnify, save, and hold harmless, the St. Bernard Parish Government, all departments, Agencies, Boards and commissions, its officers, agents, servants, employees and volunteers, from and against any and all claims, damages, expenses, and liability arising out of injury or death to any person or the damage, loss or destruction of any property which may occur, or in any way grow out of, any act or omission of Arabi Association, its agents, servants, and employees, or any and all costs, expense and/or attorney fees incurred by Arabi Association as a result of any claims, demands, suits or causes of action, except those claims, demands, suits or causes of action arising out of the negligence of the St. Bernard Parish Government, Departments, Agencies, Boards, Commissions, its officers, agents, servants, employees and volunteers.
