AN ORDINANCE TO **AMEND** CHAPTER 22, ZONING; SECTION 22-7, SITE DEVELOPMENT STANDARDS; SUBSECTION 22-7-2, PLANTING, MAINTENANCE AND REMOVAL OF TREES ON PUBLIC LAND; TO CREATE AND ADD SUB - SUBSECTION 22-7-2.12, DUTIES OF PLANTER OR PLANTING ORGANIZATION PERMIT FOR PLANTING ON PUBLIC LAND OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

### **ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:**

**SECTION 1.** The St. Bernard Parish Council, as the Governing Authority of the Parish, does **AMEND** Chapter 22, Zoning; Section 22-7, Site Development Standards; Subsection 22-7-2, Planting, Maintenance and Removal of Trees on Public Land; to create and add Sub -Subsection 22-7-2.12, Duties of Planter or Planting Organization Permit for Planting on Public Land of the St. Bernard Parish Code of Ordinances is hereby amended as per attached Exhibit "A".

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon approval of the State of Louisiana. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council and then approved by the State of Louisiana pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expressing and declaring that it would have adopted the remaining portion of this ordinance with the invalid portions omitted.

**Chapter 22 – Zoning**

**Section 22-7 – Site Development Standards**

**Sub Section 22-7-2 – Planting, Maintenance and Removal of Trees on Public Land**

**Sub- Subsection 22-7-2.12 Duties of Planter or Planting organization Permit for planting on public land**

Sub- Subsection 22-7-2.12 Duties of *Planter or Planting organization Permit* for planting on public land

- a. No person shall plant, spray, fertilize, prune, or remove, or otherwise disturb any tree on any street or municipal owned property without:
  1. Obtaining a permit free of charge from the Department of Community Development.
  2. Prior to any activity taking place, submitting a plot plan to the Department of Public Works for an assessment of location of utilities.
  3. If the proposed activity is to take place on a state highway, obtaining a written approval from the LADOTD.
- b. If the trees are not maintained by the planter or planting organization, the parish will reserve the right to remove the trees. A non-maintained tree will be defined as if the following conditions exist for more than one grass cutting season: a non-weeded base, a canopy that a tractor cannot pass under, or if it interferes with power lines and Entergy is unwilling to assist. The parish will make reasonable exceptions during a tree's early life cycle that a weeded base will suffice as canopy maintenance.
- c. Utility companies or the department of public works shall be exempt from permitting requirements during major storms or situations which cause interruptions of service or immediate threat to public safety or where immediate action is required in accordance with established parish government safety policy and procedures.
