AN ORDINANCE TO APPROVE **DOCKET Z-2025-008**, PETITION OF OLIVIER REAL ESTATE HOLDINGS, LLC FOR A CONDITIONAL USE FOR A BURROW OR EXCAVATION PITS. SITE LOCATION: LOT G2: NW ¼ OF SECTION 26, SOUTH ½ OF SECTION 26, PORTION OF SECTION 27, PORTION OF SECTION 34 & PORTION OF SECTION 35, ST BERNARD PARISH, LOUISIANA.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council does hereby approve **Docket Z-2025-008**, petition of Olivier Real Estate Holdings, LLC for a Conditional Use for a burrow or excavation pits.

SITE LOCATION: LOT G2: NW ¼ OF SECTION 26, SOUTH ½ OF SECTION 26, PORTION OF SECTION 27, PORTION OF SECTION 34 & PORTION OF SECTION 35, ST BERNARD PARISH, LOUISIANA.

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.




