ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council does hereby approve **Docket ST-2025-001**, petition of Judy Kieff for a street renaming.

Street Name Change Report:

- Name of Applicant: Judy Kieff
- Current name of street: Stay Park Drive
- Proposed street name: Kieff Lane
- List of each intersection affected: This is a private street and two lots will be affected by the proposal

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
