AN ORDINANCE TO APPROVE DOCKET **Z-2025-010**, PETITION OF MBK INVESTMENTS, LLC FOR A ZONING CHANGE FROM C-1 (NEIGHBORHOOD COMMERCIAL) ZONING TO C-2 (GENERAL COMMERCIAL) ZONING TO ALLOW A MOTOR VEHICLE DEALERSHIP. SITE LOCATION: 3200 E JUDGE PEREZ DRIVE, MERAUX LA 70075.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council does hereby approve **Docket Z-2025-010**, petition of MBK Investments, LLC for a zoning change from C-1 (Neighborhood Commercial) Zoning to C-2 (General Commercial) Zoning to allow a Motor Vehicle Dealership.

SITE LOCATION: 3200 E JUDGE PEREZ DRIVE, MERAUX LA 70075.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.




