## **ORDINANCE SBPC #2708-12-25**

AN ORDINANCE **REPEALING ORDINANCE SBPC #1993-08-17**, WHICH WAS **AMENDED BY ORDINANCE SBPC #2484-04-23**, AN ORDINANCE TO ESTABLISH A SPECIAL REVENUE FUND "TREE FUND" AND IMPLEMENT STIPULATIONS FOR ALL REVENUES AND EXPENDITURES IN THE ST. BERNARD PARISH ANNUAL OPERATING AND CAPITAL BUDGET.

**SECTION 1.** That Ordinance SBPC #1993-08-17, which was amended by Ordinance SBPC #2484-04-23, an ordinance to establish a special revenue fund "Ride Share Fees" and implement stipulations for revenues and expenditures in the St. Bernard Parish Annual Operating and Capital Budget is hereby repealed in its entirety.

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
