AN ORDINANCE TO **AMEND** CHAPTER 9, FINANCE; ARTICLE I, IN GENERAL; TO CREATE AND ADD SECTION 9-12, NON-RECURRING OR UNBUDGETED REVENUES OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** Chapter 9, Finance; Article I, In General; to create and add Section 9-12, Non-Recurring or Unbudgeted Revenues of the St. Bernard Parish Code of Ordinances as per attached in Exhibit "A".

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon the authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.



**Ordinance SBPC #2711-12-25**

**Chapter 9 – Finance**

**Article I. – In General**

**Section 9-12 – Non-recurring or Unbudgeted Donations and Legal Settlements/Judgments**

If the Parish receives any non-recurring or unbudgeted donation or legal settlement/judgment after adoption of the annual operating budget, and such revenue was not estimated or appropriated in the adopted budget, that revenue shall not be expended until it is budgeted through an individual budget amendment approved by the Council.

**(a) Reporting of smaller amounts.**

(1) Donations or legal settlements/judgments may be deposited into the appropriate fund upon receipt but must be reported to the Council in the next regular financial statement and must be budgeted through their own individual budget amendment prior to any expenditure.

**(b) Budgeting requirement.**

(1) Each donation or legal settlement/judgment must be presented to the Council as its own standalone budget amendment.

**(c) Intent.**

(1) The purpose of this section is to ensure transparency and Council oversight of unbudgeted donations and legal settlements/judgments.
