## RESOLUTION SBPC #2600-12-25

A RESOLUTION ADOPTING THE STATE OF LOUISIANA, EXECUTIVE DEPARTMENT, OFFICE OF THE GOVERNOR, PROCLAMATION NO. 71 JML 2025 AND PROCLAMATION NO. 74 JML 2025, AS DECLARED HOLIDAYS FOR ST. BERNARD PARISH GOVERNMENT EMPLOYEES.

**WHEREAS**, it has come to the attention of St. Bernard Government that Governor Jeff Landry issued Proclamation No. 71 JML 2025 and Proclamation No. 74 JML 2025; and,

**WHEREAS**, St. Bernard Parish Government is to be closed on 12/26/2025 and 01/02/2026 to coincide with State Executive Department, Office of the Governor, Proclamation No. 71 JML 2025 and Proclamation Number 74 JML 2025, which proclaims these dates to be State Holidays.

**WHEREAS**, The St. Bernard Parish Council, the governing authority of St. Bernard Parish, declares December 26, 2025 and January 2, 2026 to be legal holidays in conformity with Governor Jeff Landry's Proclamation No. 71 JML 2025 and Proclamation No. 74 JML 2025.

**NOW, THEREFORE BE IT RESOLVED**, that the Parish Government is to be closed on December 26, 2025 and January 2, 2026.

**BE IT FURTHER RESOLVED** that if any section, clause, paragraph, provision or portion of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Resolution with the invalid portions omitted.
