AN ORDINANCE TO APPROVE DOCKET Z-2017-009, PETITION OF ELIZABETH FISHER ROBIN FOR A ZONING CHANGE FROM "R-1, (SINGLE FAMILY RESIDENTIAL)" TO "C-2, (NEIGHBORHOOD COMMERCIAL)" FOR THE PROPERTY LOCATED AT 2001 BARTOLO, MERAUX, LA 70075.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That St. Bernard Parish does hereby approve Docket Z-2017-009, Petition of Elizabeth Fisher Robin for a Zoning Change from "R-1, (Single Family Residential)" to "C-2, (Neighborhood Commercial)" for the following described property:

Lot 2-A 76.94'ft on E. St. Bernard Hwy X rear width of 71' x depth of 189.66' X OPP depth of 160' = 12,411Sq Ft.

Property Location: 2001 Bartolo, Meraux, LA 70079

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.
